

Technical Information about MANT-5'-CMP

Name: 2'- / 3'- O- (N'- Methylanthraniloyl)cytidine- 5'- O- monophosphate, sodium salt

Description: MANT-5'-CMP is an analogue of the natural structure 5'-CMP where either the ribose 2'-hydroxy or the 3' hydroxy group is esterified by the fluorescent methylisatoic acid.

Properties: MANT-5'-CMP is a fluorescent analogue of 5'-CMP with λ_{EXC} 355 nm and λ_{em} 448 nm. The MANT fluorophore has a certain sensitivity for its environment and can change its spectral properties upon binding.

Specification: Lyophilized or crystallized sodium salt. Other salt forms are available upon request. Equal concentrations of MANT-5'-CMP can appear very different in volume due to sensitivity of the lyophilized form to humidity. The compound can even contract to small volume droplets. Normally the product is located in the conical bottom of the tube. Micromolar quantities are determined by UV at λ_{max} .

Purity: Typical analysis is better than 97% (HPLC / UV / 253 nm) for mixture of 2'- and 3'- isomers at time of quality control and packing. However, actual purity depends on storage and transport conditions. The product is not sterile and has not been tested for endotoxins.

Solubility: MANT-5'-CMP is soluble in water (\geq 21 mM, limits have not been determined). Please rinse tube walls carefully and preferably use ultrasonic or vortex to achieve total and uniform mixing. When opening the tube please make sure that no substance is lost within the cap.

Stability and Storage: If MANT-5'-CMP is protected from light, it is sufficiently stable at room temperature and does not need special care during handling or shipment. Nevertheless, we recommend that the compound should be stored in the freezer, for longer storage periods preferably in freeze-dried form.

Toxicity and Safety: Since 5'-CMP has multiple tasks in every organism, it is not unlikely that its analogues could interfere with many cell regulation processes *in vivo*. However, due to the rather small quantities to work with, no health hazards have been reported. Nevertheless please keep in mind, that the *in vivo* properties of this compound are not sufficiently characterized up to now. Avoid skin contact or ingestion and allow only trained personnel to handle the product.
